

NAME OF UTILITY           CHOCTAWHATCHEE ELECTRIC COOPERATIVE, INC          

RESIDENTIAL SERVICE—SOLAR BLOCK A

AVAILABILITY – Available throughout the area served by the Cooperative to residential customers who are provided single-phase service, or three phase service under the RS rate.

APPLICABILITY – Applicable to all members for residential uses.

CHARACTER OF SERVICE – Single-phase or three-phase, 60 cycles and approximately 120 volts or higher, at Cooperative’s option.

LIMITATIONS – Subject to all the rules and regulations of this tariff and general rules and regulations of the Cooperative. Standby or resale service not permitted.

SOLAR BLOCK – A solar block shall consist of a proportional share of the output of the solar facility for each billing period. These kWh’s shall not be billed for the Energy Charge – Purchase Power (currently \$0.05347) and shall not be charged the power portion of the Wholesale Power Adjustment.

RATE – RS-SB

The charges for the electricity supplied by the Cooperative to a Residential Customer served under Rate RS-SB shall be determined as follows:
