RATE SCHEDULE GPC

<u>AVAILABILITY</u> - Available to all customers served throughout the Cooperative's service area from existing lines of adequate capacity. Rate Rider GPC customers will be served from the existing electrical system. Customers may purchase green power energy in 100-watt blocks. Multiple blocks may be purchased. Power purchased or produced from green power facilities may not be specifically delivered to the customer, but will displace power that would have otherwise been produced from traditional generating facilities. Participation under this rate rider is limited to a total of 34,166 blocks per year.

<u>APPLICABILITY</u> - Applicable to all residential and commercial/industrial customers in good financial standing with the cooperative. All rates, terms and conditions of the rate schedules under which the customer is otherwise served are applicable.

<u>CHARACTER OF SERVICE</u> - Green Power Choice Rate Rider GPC customers have elected to purchase energy blocks that are generated from a facility that uses a renewable energy source (i.e., biomass, landfill methane, solar, wind or hydro). Each energy block is equal to 100 kWhs. Multiple blocks may be purchased. Blocks must be purchased on an annual basis.

<u>LIMITATIONS</u> - Members requesting service under this rider will be accepted on a first-come, first served basis subject to availability of renewable energy blocks. If additional energy blocks are not available, members requesting service under the optional rider may request their name be put on a waiting list until additional energy blocks can be secured to serve their request .Subject to all the rules and regulations of this tariff and general rules and regulations of the Cooperative. Standby or resale service not permitted.

<u>RATE</u> -

Green Power Choice Charge

\$2.00 Per 100 kWh block plus the amount for the rate schedule the customer is otherwise served.

<u>TERM OF SERVICE</u> - Service under the Green Power Choice Rate Rider (GPC) shall be for a period of one (1) year.
