### Voting by Mail

- After completing your ballot and registration card, detach both and place in the enclosed return envelope.
- **Do not mail to CHELCO.**
- Mail to Survey & Ballot Systems, 7653 Anagram Drive, Eden Prairie, MN 55344-9603.
- Mailed envelopes must be received no later than April 8, 2025. Please allow sufficient time for delivery.
- Elections are at large. To meet a quorum as established in the bylaws, it is important to **vote for one (1) candidate from each district**, regardless of the district you are in, even if candidates are unopposed.
- You should also vote either Yes to approve or No to disapprove the proposed bylaws revision.
